OSPI UPDATE

With the change in weather, fallen leaves crunching beneath your feet, fall is a perfect time to reflect and embrace change. As a health science educator and practitioner, you have experienced the changes in the constantly evolving healthcare industry, from policy to patients and everything in-between. As the health science practice moves to a team based, patient-centered care approach this same sense of community and team building can become the core of our health science teacher organization. Each of you are essential to our organization becoming the best it can be and to developing a shared understanding of what matters to you as health science educators. Our Health Science Teacher leadership team has spent time developing a strong foundation for the organization and a strategic plan for the future. We need you to help steer us in the right direction. UPDATES

This fall has been busy. OSPI provided technical assistance across the state in one day updates covering many issues from course and program approval to the Perkins V changes.

HB1599, the multiple pathways bill, is another topic we have been watching. One of the pathways is the CTE sequence of courses. More clarity will be coming in the near future when the State Board of Education considers the final adoption of the rules. A sequence of Career and Technical Education courses is defined as two or more high school credits of CTE courses in a progression tailored to the student's goals and relevant to the post-secondary pathway(s) outlined in the student's High School and Beyond plan. The question is whether the sequence of courses may be comprised of courses within the same CTE program area or courses within more than one CTE program area.

Perkins V is requiring the field to review their Programs of Study in each of the program areas. Each of you may be asked to review the courses being offered in the Health Science career cluster and the related pathways. A model template will be provided to districts with suggestions for course sequences, industry recognized credentials, dual credit opportunities, and work-based learning opportunities based on employment need. This provides an opportunity to step forward and provide guidance and direction to your districts in developing the Health Science Program of Study. Engage your advisory board as the advocate and voice for what the industry needs to provide for the Healthcare Workforce of the future. Review employment data. There are a number of great resources: the Allied Health Center of Excellence, Washington's Health Workforce Sentinel Network, and the Washington Pathways Project.

STANDARDS UPDATE

The National Health Science standards were updated in May 2019. (healthscienceconsortium.org). Districts will need to update their course frameworks locally to reflect the updated standards. These standards are the foundational principles for the development of all health science education curriculum. With the standards update the curriculum enhancement resources will be updated in the near future. As a member state districts receive a reduced rate on the enhancement tool and the Work Based Learning resource.

CTSO's

HOSA and WCTSMA have been extremely active this fall. Both offered fall leadership opportunities for their members. WCTSMA started off the year with their event at CenturyLink field. While HOSA offered an Advisor and student conference at Hazen High School. Both are wonderful opportunities for students to develop their leadership skills and build a community with others who are interested in the healthcare field.


WCTSMA UPDATE
